# VIII. Details of Teaching/Work Experience:

# a. Undergraduate:

- i. Medical Students Infectious Disease posting: I am responsible for developing and implementing the adult infectious disease rotation for medical students as designated by the new curriculum for undergraduate medical education. The rotation spans a duration of two weeks. The rotation activities include seminars and tutorials on core topics in infectious disease such as HIV, viral hemorrhagic fever, infection control, malaria, emerging infections and sepsis. This posting also incorporates case-based teaching with the patients admitted by the infectious disease unit onto the wards. The posting also provides outpatient exposure at the UCH antiretroviral therapy clinic domiciled in the Infectious Disease Institute of the College of Medicine. This is a novel experience for medical students at the University of Ibadan as adult out-patient HIV care which is domiciled outside of the Medical Outpatient (MOP) clinics at the University College Hospital was hitherto not a part of their clinical experience. I am also involved in organizing and administering the end of posting examination for this posting.
- ii. Medical students' Medicine I, II and III posting: I conduct weekly clinical teaching during ward rounds as well as tutorials for the Medicine I, II and III medical student postings
- iii. Integrated Lectures for medical students: I give 3 lectures per set during the integrated lecture series. Each set is made up of about 170 students.

Medical student assessment: I have been involved in providing examination questions for clinical and written examinations for the end of posting examinations and the MBBS Part IV examinations in medicine as well as marking scripts and serving as invigilator and examiner in the clinical and oral examinations.

This study is in the start-up phase and aims to reduce early mortality in patients with advanced HIV disease by the use of short-term prophylactic azithromycin in addition to standard of care.

ii. Carbapenem Resistant Enterobacteriaceae in West Africa CRESTA

This study aims to establish prevalence, antimicrobial susceptibilities and molecular epidemiology of Carbapenem Resistant Enterobacteriaceae in Nigeria, Ghana and Sierra Leone. This multicenter study aims to describe the prevalence of invasive salmonellosis amongst adults and children presenting at the University College Hospital with an acute febrile illness. It is also investigating the antimicrobial susceptibilities of isolates obtained as well as clinical outcomes (including complications such as perforation) of infected patients. The first phase of the study has been completed and the manuscript has been published, and the second phase is now in progress.
